Regular Board Meeting

The Schaller-Crestland Board of Education, along with the Galva-Holstein Board of Education met in regular session on July 12, 2021 in the media center of the Galva-Holstein School, Holstein, IA. The following board members were in attendance: Kory Blum, Tim DeLance, Alan Movall, and Mike Schmitt. Others present: Supt. Wiebers, Brd. Sec'ry Wandrey, Mike with The Holstein Advance, and Principals Bellinghausen and Rinnan. Absent: Christy Horan.

Call to order at 7:01 pm. by acting president, Vice President Blum.

Motion by DeLance, second by Movall to approve the agenda as posted. Motion carried 4-0.

Vice President Blum opened the meeting at 7:02 pm for the public hearing regarding the ESSER III Plan. The district will receive \$605,082 in funds, with \$121,016 required to be spent towards learning loss. Supt. Wiebers suggested many qualified options for the district. The district has up to three years to use the funds. With no further comment, the hearing was closed at 7:08 pm.

Motion by DeLance, second by Schmitt to approve the June 14th regular board meeting minutes as published. Motion carried 4-0.

Motion by Mike, second by DeLance to approve the payment of district bills. Schmitt reviewed prior to the meeting. Motion carried 4-0.

Brd. Sec'ry Wandrey briefly reviewed the June 2021 financial report. This report will not be approved until after the final district audit is completed.

Motion by Schmitt, second by DeLance to approve the hiring of Bret Warnke at .6 FTE, Middle School Social Studies at \$19,000 and employee/spouse insurance. Motion carried 4-0.

Motion by DeLance, second by Movall to approve the hiring of Kelly Wiener, Middle School Language Arts at \$51,250. Motion carried 4-0

Motion by DeLance, second by Schmitt to approve the hiring of MaryKay Todd, at .6 FTE, Middle School Science at \$36,240. Motion carried 4-0.

Motion by DeLance, second by Schmitt to approve the hiring of Rochelle Theis as the district health aide at \$12.00 an hour. Motion carried 4-0.

Motion by DeLance, second by Movall to accept the A&E Milk bid for the 21/22 school year. Motion carried 4-0.

Motion by Movall, second by DeLance to approve the fees for the 21/22 school year. Moving the substitute pay from \$120 to \$125 per day. Motion carried 4-0.

The board tabled adding a shared resource officer at the high school.

Motion by DeLance, waving the second reading, second by Movall to approve the policy updates as presented. Policy updates are to 401.14, 502.3, 5023R1, 711.2R2, 804.6, 804.6R1, 905.3. Motion carried 4-0.

Supt. Wiebers will be sending the board members a list of Legislative Priorities. Those will need to be selected at the next board meeting, August 9th. In other discussion, Supt. Wiebers stated that school registration will be starting hopefully at the end of July. More information will be published on the districts website and social media. Registration will be all online with the exception of new students. There will be one day that parents will be able to come in and get assistance if necessary. Painting updates have been completed in Early and has now started in Schaller. Also, the front parking project has started and is still expected to be completed the first part of August.

With no further discussion, motion was made by DeLance, second by Movall to adjourn at 8:24 pm. Motion carried 4-0.
